**RESOLUTION TO ADOPT THE
2024 VILLAGE GENERAL FUND BUDGET, DESIGNATED FUND BUDGETS, AND
SHARED SERVICES BUDGETS; LEVY TAXES; AND
IMPOSE DELINQUENT WATER AND SEWER CHARGES
ON THE TAX ROLL**

BE IT RESOLVED, that the Fox Point Village Board hereby adopts the 2024 Village Budget (General Fund 10) in the amount of \$7,870,048.00.

BE IT RESOLVED, that the Fox Point Village Board hereby adopts the 2024 levy, and levies taxes (to be due in 2024) in the amount of \$7,882,114.00.

BE IT RESOLVED, that the Village Treasurer be and is hereby authorized and directed to spread upon the 2023 tax roll against respective properties delinquent water and sewer charges in the amount of \$149,880.35.

BE IT RESOLVED, that the Village Treasurer be and is hereby authorized and directed to spread upon the 2023 tax roll in proportions to the 2023 assessed valuation the following tax levies: State of Wisconsin/County of Milwaukee - \$7,093,334.20; Milwaukee Sales Tax Credit – (\$1,876,062.28) Village of Fox Point - \$7,882,114.00; MMSD - \$2,045,501.09; Nicolet High School - \$7,557,091.82; Fox Point J2 School District #2 (Fox Point-Bayside) - \$11,473,476.34; Maple Dale Indian Hill School District #8 (Maple Dale-Indian Hill) - \$2,249,558.47; and MATC - \$1,332,695.83.

BE IT RESOLVED, that the 2024 North Shore Water Commission Operating and Maintenance Budget in the amount of \$1,577,518.00 and is hereby approved, subject to approval by the City of Glendale and the Village of Whitefish Bay.

BE IT RESOLVED, that the 2024 Fox Point Water Utility Budget (Fund 50) in the amount of \$4,587,025.00 be and is hereby adopted.

BE IT RESOLVED, that the 2024 Sewer Utility Budget (Fund 21) in the amount of \$1,592,196.00 be and is hereby adopted.

BE IT RESOLVED, that the 2024 Fox Point Stormwater Utility Budget (Fund 25) in the amount of \$900,000.00 be and is hereby adopted.

BE IT RESOLVED, that the 2024 Debt Service Budget (Fund 30) in the amount of \$2,161,101.00 be and is hereby adopted.

BE IT RESOLVED, that the 2024 Recycling Budget (Fund 22) in the amount of \$301,045.00 be and is hereby adopted.

BE IT RESOLVED, that the 2024 Capital Projects Budget (Fund 40) in the amount of \$4,973,534.00 be and is hereby adopted.

BE IT RESOLVED, that the 2024 Municipal Pool Budget (Fund 23) in the amount of \$102,771.00 is hereby adopted.

BE IT RESOLVED, that the 2024 Inspection Services Budget (Fund 24) in the amount of \$213,170.00 be and is hereby adopted.

BE IT RESOLVED, that the 2024 North Shore Fire Department Budget in the amount of \$15,581,964.00 is hereby adopted, with Fox Point's operating share being \$1,216,969.00 and capital share being \$57,617.00.
