**Re:** **Administrative Report for the Week Ending November 9, 2018**

### ADMINISTRATION

1. New artwork by local Artist Brad Killam is on display in the Fox Point Village Board room. His work has been featured in over 40 solo and two person exhibitions since 1991. Make sure to stop out and check it out!
2. Village Manager and Assistant Village Manager met with potential pool consultants.
3. Staff had meeting with CivicPlus, the Village's website provider to discuss website improvements.
4. AVM met with R&R Insurance to discuss the 2019 insurance coverages.
5. Village Manager and Assistant Village Manager participated in the North Shore Manager meeting on Thursday, November 8 in Shorewood.
6. Election was held on Tuesday, November 6. The Village Clerk and Deputy Clerk did a fantastic job! Thanks Kelly and Jeanne!

### DEPARTMENT OF PUBLIC WORKS

1. Staff met with the contractor for the Goodrich Lane ravine project and, after the rain and snow events this past week, made the decision to postpone work on the ravine until next spring. The rain in August and September has delayed quite a bit of landscape restoration activities along with the work in the ravine due to the wet conditions.
2. Staff has been discussing landscape restoration activities along Club Circle and Lilac Lane. Due to the burying of additional pipe and the placement of the shoulder (which occurred this week), this activity may be postponed until next spring. Staff will be meeting with the contractor next week to discuss the options, including the temporary stabilization of the disturbed areas with winter wheat and mulch and filling in low spots in various areas along the project route.
3. Leaf collection activities are quite heavy. Two crews are working 10 hours a day and will be working 8 hours this Saturday to stay on top of all of the leaves placed out for collection.
4. A limb went down on Sunday and took out power to Lift Station No. 1. The generator worked well and power was restored at 9 pm.
5. The Village mechanic received his CDL temps.
6. The Water Utility worked on meter reading follow up, spoke with the property owner at 250 West Bergen regarding his water pressure/flow after the water main break a week or so ago, performed many locates for the projects that are ongoing, cleaned up the

- equipment from the water main breaks, and removed the water meter at a residence on Whitney.
7. Water Utility staff is looking for locations for the spoils (fill that is excavated during a water main break). A couple of locations have been identified but we may need to find another spot or two.
  8. DPW staff continued with yard waste collections, closed down the tennis courts for the season, installed white posts, and repaired mailboxes.
  9. Staff met with our consultant regarding proposed ordinance changes to the erosion control and stormwater management sections. The final stormwater management plan was also delivered to staff.
  10. Staff began coordinating the geotechnical review of a proposed retaining wall for a property on Wye Lane.

### POLICE DEPARTMENT

1. Officers met with citizens on two separate occasions to accept firearms and ammunition for destruction. The items will be stored for safekeeping until destroyed by the State Crime Lab. Firearms turned over for destruction are run through a metal shredder to prevent any future use.
2. Officers met with a resident on November 2, 2018 who reported that an unknown person had used their personal information in an attempt to modify their bank accounts. The account was tampered with, but access was not gained. The resident will be monitoring for other identity theft indicators.
3. Officers conducted a traffic stop which resulted in an arrest on November 3, 2018 in the 7500 block of North Port Washington Road. The officer stopped the vehicle for a license violation and determined that the driver was operating with a revoked license from a previous OWI. While speaking with the driver, the officer observed signs of impairment and conducted field sobriety tests. The driver was arrested for Operating While Intoxicated based on the officers observations and investigation. Charges will be referred to the district attorney for the OWI along with possession of narcotics after pills were located that tested positive for MDMA.
4. Officers conducted a traffic stop that resulted in an arrest in the 300 block of East Calumet Road on November 3, 2018. The officer stopped the vehicle for a registration violation and during the course of the traffic stop, the officers observed open intoxicants in the vehicle and baggies of a green leafy substance that tested positive for THC. The occupants of the car were arrested for possession of marijuana and will appear in the municipal court.
5. Officers responded to an entry to vehicle report on November 5, 2018 in the 7500 block of North Santa Monica Boulevard. The officer met with a citizen who had the window of the car smashed and property taken from inside the glove compartment. No valuables were visible in the car when the entry occurred. The officers are working with other agencies in the north shore who experienced similar incidents during the same time period.
6. Officers provided assistance to the Glendale Police Department on November 7, 2018 for a multiple vehicle accident on Interstate 43 at Green Tree Road. The accident required the

interstate to be shut down and traffic diverted to local streets. Fox Point officers provided traffic control at the major intersections to aid in the movement of freeway traffic.

### **Did you know?**

Now is the time to enroll in or change 2019 Marketplace health insurance. The 2019 Open Enrollment Period runs from Thursday, November 1, 2018, to Saturday, December 15, 2018. The Health Insurance Marketplace is for people who don't have health insurance coverage through a job, Medicare, Medicaid, the Children's Health Insurance Program (CHIP), or another source that provides qualifying health coverage. You can sign up for health insurance on your state's health insurance exchange or individual marketplace only during the annual open enrollment period, unless you have a "qualifying life event," such as getting married or having a baby. If you take no action, you will be automatically re-enrolled in your current policy. If you buy health insurance through your workplace, your employer will inform you about its open enrollment period.

Here are some helpful tips to guide you:

- If you want to keep your doctors, make sure that they still participate in the plans you're considering. Check the provider lists on [healthcare.gov](http://healthcare.gov), but also double check the provider list on the carrier's website or contact your current provider directly.
- There is no penalty for not buying coverage in 2019. However, it is a good idea to have coverage if you can afford it to avoid catastrophic bills for any unexpected health issues that may arise. You may not enroll at will throughout the year, so waiting for a health issue before attempting to enroll is not an option.
- You have short term plan options. Traditionally, short-term plans have been used to bridge a coverage gap of a few months or less, but a new ruling suggests they can be adopted as a long-term solution and can be renewed for up to 36 months. These plans do have limitations beyond what the ACA insurers meet. Insurers can charge you more based on preexisting conditions or deny you coverage.
