**Re:** **Administrative Report for the Week Ending August 28, 2020**

### ADMINISTRATION

1. Forms PC-201 2020 Request for Charge Back of Rescinded or Refunded Taxes (3) were filed with the State of Wisconsin DOR by Treasurer's Office.
2. Staff continues to prepare for the 2021 Budget.
3. Staff participated in meeting w North Shore Library Director.
4. The City of Glendale, declining continued negotiations or mediation, gave notice of intent to withdraw from the North Shore Library.
5. Staff participated in North Shore Health Department EOC meeting.
6. Village Manager was one of two panelists of opening keynote session for 2020 Chief Executives Conference sponsored by the League of Wisconsin Municipalities.
7. Staff rescheduled the next Comprehensive Plan Special Committee meeting to September 14, 2020 at 8:00am.
8. Reminder: Village Board meetings will be held strictly via Zoom until the Village is able to update the Audio/Visual system in the Board Room.

### DEPARTMENT OF PUBLIC WORKS

1. New employees Nicholas Ness and Chris Roeske started in the DPW on Monday.
2. Continued asphalt work around raised manholes which may be hazards when snow plowing.
3. Working on a ditching project at the 8100 block of Santa Monica.
4. Working on forestry request of removal and pruning in the forestry department.
5. Gravel shouldering on Village streets.
6. Making sure all of the drainage areas are checked for the expected rain.
7. In the shop, Steve and Glenn are working on keeping the rubbish scooters operational.
8. WSO grading is working on the storm grates at 7100 Beach Drive.
9. The painting contractor is working on the trim and the rear doors on Village Hall.
10. Water Utility Operators continue to do valve turning maintenance.
11. The Water Utility called in the locate ticket for replacing and moving the hydrant at 7230 Longacre Rd. It will be moved across the street. The work is scheduled for Tuesday, September 1st and should be completed on September 2nd.

12. The Water Utility started preparing for sandblasting hydrants and painting; they will be painted red.

### POLICE DEPARTMENT

1. Officers responded to several reports of theft when political signs are being taken from the front yard without permission. Residents have observed the subjects taking the signs and leave the area in a vehicle.
2. Officers responded to a report of disorderly conduct and a physical altercation at a CBRF. The officers were able to de-escalate the event and no criminal charges will be filed due to the subject's cognitive disabilities.
3. Officers responded along with North Shore Fire Rescue to a report of a possible drowning. Upon arrival, officers assisted fire personnel in removing the person from the water and life saving measures were started by EMS personnel. The officers assisted fire / rescue personnel until the person was transported to the hospital. The officer's investigation showed this to be a medical incident and no indication of criminal activity.
4. Officers responded to a report of a hit and run accident involving a parked vehicle. The officer completed a state accident report and photographed the incident; however, no additional suspect information is available.
5. Officers responded to a report of damage to property when graffiti was spray painted on the village roadway. A resident who observed the graffiti spray painted a different message over the initial graffiti message. The resident acknowledged the action was damage to village property and was issued a municipal citation. Additional graffiti was located by the officer and repaired by village staff.
6. Officers responded to assist Glendale police who were attempting to stop a fleeing stolen vehicle. Fox Point officers were able to deploy controlled deflation devices (Stop Sticks) and puncture the driver's side tires on the fleeing vehicle. The vehicle stopped a short time later and the occupants were apprehended after a brief foot pursuit. All criminal matters were handled by Glendale police.
7. Officers provided assistance to a resident who was the victim of an online scam and provided personal identifying information. The resident had not suffered any loss at the time of the meeting and the officer provided information to prevent any fraud / financial loss, as well as scam prevention information.

Influenza Season – Get your flu shot!

Influenza and COVID-19 are both contagious respiratory illnesses that are caused by different viruses and typically present with similar symptoms. Although there is currently no vaccine for COVID-19, influenza vaccines are available and are highly recommended as we approach this year's flu season. It is recommended that everyone 6 months and older be vaccinated for influenza. Flu vaccines initiate the development of antibodies approximately two weeks after vaccination. These antibodies offer protection against infection with the influenza viruses used to make the vaccine. Make plans to get vaccinated as early in fall as possible to allow your body time to develop antibodies and prepare to protect you from exposure to influenza viruses.
