Re: **Administrative Report for the Week Ending May 21, 2021**

ADMINISTRATION

1. Staff attended the Audit Committee meeting held on Wednesday morning at 8:00 a.m.
2. Staff participated in the Board of Appeals meeting on Thursday, May 20, 2021 which began at 5:00 p.m.
3. Village Manager participated in League of Wisconsin Municipalities Finance call with DOR.
4. Village Manager participated in statewide LWM Roundtable.
5. New Pool Managers have started preparing for the season. Swim Lesson schedule should be available on the Village's website early next week.

DEPARTMENT OF PUBLIC WORKS

1. Staff should be wrapping up tree planting for the season this week.
2. Staff continues to maintain the park areas for summer activities.
3. Staff started installing the wind screens at the tennis courts.
4. The water main project on Regent Road started this week.
5. One of the three seasonal workers started this week.
6. Staff continues to prepare the Pool facility for the season. Next week, staff plans on filling the pool and testing the pumps.
7. Staff has been trimming/cleaning up trees that have lost limbs or have been damaged.
8. Staff dealt with a water main leak on Boyd Way just north of Calumet.

POLICE DEPARTMENT

1. Officers responded to a report of a retail theft at Best Buy, 8755 North Port Washington Road. The suspect entered the store, gathered specific merchandise and immediately exited without payment or permission to remove the items. The suspect has been identified and will be charged in relationship to another case.
2. Officers responded to assist Glendale Police on the scene of a foot pursuit and canine track. The Fox Point officer took custody of a juvenile subject and transported them to the Glendale station, while the canine officer continued their foot pursuit.

3. Officers responded to a trespassing complaint at Best Buy after a person known to the store employees as a retail theft offender was on the premises without permission. The officer’s investigation revealed that the subject concealed merchandise while on the premise and left without payment. The investigation report will be referred to the district attorney for charging and an arrest warrant.
4. Officers responded to a request for police assistance call when a vehicle was identified as being engaged in suspicious activity. The occupants of the van were driving around the neighborhood, stopping residents and asking for work. The officers located the subjects and, after identifying them, advised that they cannot solicit in the Village without a permit.
5. Officers responded to assist River Hills Police with a report of disorderly conduct. A subject was threatening another person verbally and escalated the situation to threaten their life by running them over and also with a firearm. Fox Point officers provided assistance and the matter was investigated by River Hills.
6. There has been an increase in vehicle thefts in the metro area, including window smash entries to cars to steal valuables. Officers on patrol located many open vehicle doors and garage doors to homes during the overnight hours. The officers left a crime prevention notice and reminder card for the homeowners.
